Tuition Assistance & Financial Aid Resources

Scope

Tuition assistance is available for both Residents and Non-Residents of Nebraska.

The UNMC College of Allied Health Professions (CAHP) is committed to making health professions education accessible by reducing financial barriers for students, so they may realize their career goals. The CAHP awards numerous scholarships that are exclusively for CAHP students, and the UNMC Office of Financial Aid offers a full range of financial aid services available to all UNMC students. Scholarship awards are based on various specific criteria such as financial need, academic record, GPA, or residency, to name just a few. UNMC and the CAHP work with each student to create an individual financial aid package.

Student Emergency Fund Policy:

The UNMC College of Allied Health Professions CAHP will make available on an annual basis a Student Emergency Fund as a mechanism to support currently enrolled College of Allied Health Professions (CAHP) students during an unexpected budgetary crisis that threatens their ability to progress in their plan of study. Nebraska Promise:

Nebraska Promise is a University of Nebraska expanded financial aid program that guarantees eligible **undergraduate** students will have up to 30 credit hours of tuition per year paid in grant and scholarship aid. It replaces the tuition guarantee program previously known as Collegebound Nebraska. **The program is available to undergraduate nursing, dental hygiene, and allied health professions students** meeting the Nebraska Promise eligibility criteria. It does not apply to students seeking a second bachelor's degree.

Military and Veterans Benefits:

The College of Allied Health Professions CAHP proudly supports the educational aspirations of all active duty military and veterans of the United States Armed Forces. All CAHP programs adhere to the policies of each branch of the US Armed Forces in order to work with active duty military personnel who are eligible for tuition assistance. The Department of Veteran Affairs has approved all of the CAHP academic programs for VA benefits. All men and women planning to attend a program in the College of Allied Health Professions CAHP who are eligible for educational assistance and the Vocational Readiness program administered by the Veterans Administration, including the Montgomery GI Bill® and the Post 9/11 GI Bill®, should contact the Office of Academic Records (<https://www.unmc.edu/student-success/academic-records/>) with any questions prior to registration. Additionally, UNMC is a Post 9/11 GI Bill® Yellow Ribbon Program participant.
